

Statement by the Board of Directors regarding the proposed dividend

In connection with the proposal by the Board of Directors of Alligo AB (publ) regarding dividend for the 2023 financial year, the Board hereby submits the following statement in accordance with Chapters 17–18 of the Swedish Companies Act.

The Board proposes a dividend of SEK 3.50 per share. The proposed dividend corresponds to 35.9 per cent of the Group's earnings per share for the 2023 financial year.

The Board of Directors has assessed the Company's and the Group's financial position and the Company's and the Group's ability to meet their short and long-term obligations. A total of SEK 175 million is required for the proposed dividend payment (with due consideration for the repurchased Class B shares held by Alligo AB), which means that, all other things being equal, the Group's equity/assets ratio would decrease by 1.2 percentage points as of 31 December 2023. After payment of the proposed dividend and taking into consideration the prevailing market conditions, the Company's and the Group's equity/assets ratio is still deemed to meet the demands placed on the operations conducted by the Group.

The Board's assessment is that the proposed dividend is well balanced taking into account the demands placed on the size of the Company's and the Group's equity and liquidity due to the type of business conducted, its scope and relative risks. The proposed dividend is also in line with the Company's dividend policy, which states that 30–50 per cent of earnings per share shall be distributed over a business cycle.
